1. Submit a site plan showing exact location of poultry shed(s) from any dwelling or other buildings, ie sheds etc.
2. Submit a plan showing size and specifications of proposed poultry sheds. Poultry must be kept in an enclosed shed and fenced pen located at least 9m from both your house and any of your neighbours' houses. It shall be no less than 18m from any street boundary of your property and within your building envelope.
3. Please allow approximately 450cm<sup>2</sup> per bird.

## **EXTRACT CITY OF KWINANA HEALTH LOCAL LAWS KEEPING OF POULTRY**

1. On and after 1 July 1963, an occupier of premises shall not keep or permit to be kept, poultry on any premises occupied by him/her within the area described, except under and in compliance with the following conditions:
  - a) The occupier is registered with the local authority as a keeper of poultry and the premises are also registered.
  - b) The occupier has paid to the local authority, the prescribed fee **which is payable annually (currently no fees apply for up 20 poultry)**.
  - c) The occupier has provided properly constructed enclosures and facilities for the keeping of poultry and the poultry are kept therein at all times.
  - d) The poultry do not exceed twenty (20) in number.
  - e) The occupier does not keep any poultry within 9m of any dwelling house.
  - f) All enclosures within which poultry are kept are maintained in clean condition.
2. This By-Law operates and has effect in the whole District of Kwinana.
3. The local authority may cancel or refuse the registration of any occupier in relation to any premises if the occupier is convicted in any court for an offence relating to the keeping of poultry.
4. Non-compliance with the above By-Laws renders offenders liable to be fined \$204 for each day such breach occurs.
5. The *City Planning (Buildings) Uniform General By-Laws 1989* provides that a fowl house shall be no less than 18m from the boundary of any street boundary of the Lot.
6. Your cooperation in the clean keeping of poultry and eradication of the fly nuisance in this District will be appreciated.
